DISTRICT FRANCHISE RULE

New joining district partner are required to submit documents before joining

Which includes: -

- Aadhar card
 - Pan Card
 - Ration card
 - Mark sheet (any one)
 - Passbook copy
 - Character certificate
1. Free membership
 2. One person in one district
 3. Only those who have no criminal record can become a partner.
 4. The term of the partner will be one year, two years & five years.
 5. Any expense will be incurred by the 2nd party for the field officer, marketing officer & office staff, it will be spent which will be deducted from the main profit of the company. After deducting these expenses 50% of the profit left will be of the 1st party and 50% will be of the 2nd party.
 6. There will be a franchise in the district & a sub franchise. If the franchise does not do the right work then the work will be assigned to the sub-franchise, But the work that has been taken by the franchise, if he doesn't disturb without giving any reason even then that work 10% of his profit will continue as long as it lasts.
 7. The management will not pay any separate remuneration to the partner for the work.
 8. The work being given by the 1st party to the 2nd party will follow all the rules with honesty & diligence.
 9. All accounts of the business will be maintained. Every month the 2nd party will get the 1st party all types of bill, receipt & vouchers etc.
 10. If any dispute arises it will be settled in Raipur court.
 11. Any work will be done by the 2nd party after that in case of any accident the family of the 2nd party will be given 10% profit of the work done but only till that work continues.
 12. Even if the partnership is ends by the 2nd party, 10% of the profit in the work done by them will be given as long as that work continues.
 13. The 1st party is not satisfied with the work of the 2nd party & the 1st party ends the partnership, then 50% of the profit of the work done will continue.
 14. The company will work with full honesty. The 1st party will provide assistant to the 2nd party as much as possible.
 15. Any work done by 2nd party he will get 50% after deducting all the expenses.
 16. 2nd party will not be given any benefit if found involved in any act like causing harm to the company.
 17. The 2nd party will never work at that place or send it to any other place without being informed about the dispute or for its own interest, nor will it do any work at that place which will cause loss to Alert SGS Pvt. Ltd., Even in such a situation, the company will not provide any profit share to you.

18. The 2nd party will get the marketing done by themselves and will recruit the employees, but will send the information of the employees to the company
19. 2nd party will inform Alert SGS Pvt Ltd before taking any decision
20. Company is independent that if 2nd party does not work well then 1st party is free to give franchise to someone else.
21. 2nd party will have the right to decide which employee to hire and determine the remuneration and inform the company
22. 2nd party will not recruit such employees whose mental condition is not right and character, who has ever been involved in working against the state and the country, will not hire such an employee.
23. 2nd party will not take any money or demand any kind from any employee in the name of job.
24. 2nd party will only take uniform charge Rs 2000, which will inform the company and send it to the company's account.
25. If both the parties take the uniform from the company together, then they will get the uniform for Rs. 1500 but the employee will get it for Rs. 2000 only.
26. Will take payment for uniform only after giving uniform to any employee.
27. It will be the responsibility of the 2nd party to bill the company in which the guard is being posted and take the full salary only after that the party will get a share of the profit.
28. 2nd party will see the whole management; the side will not tell one side whether you want to come in the field or not.
29. The 1st party will have full right to check whether the work going on in the district is going on right or not.
30. Any document related to company will be supplied from Alert SGS Pvt Ltd office Raipur.
31. The work related to the document is not to be done by the 2nd party at all.
32. Whatever documents are required by the company; they can get it directly from the Alert SGS Pvt Ltd office.
33. The 2nd party will have the right to open an office anywhere in the district after completion of three months but will not charge more than Rs. 5000 as rent.
34. 2nd party will not get any kind of money without starting the work.
35. It is mandatory for the 2nd party to start the work of 200 guards in the district within 6 months; otherwise the sub franchise will be given a chance
36. Entire management will be done by 2nd party only Salary alert of all employees will be from SGS Pvt. Ltd. office only which will be directly credited to employees account
37. Employee's PF+ESIC and payment work alert will be done from SGS Pvt Ltd office Raipur
38. It will be the responsibility of the 2nd party to take the work order from the company in which the guards are deployed, only after that the guards will be deployed.
39. It will be the responsibility of the 2nd party that timely billing should be done in the company and timely payment should be made to the employees.
40. The 2nd party will have full right to see the entire management of whatever work is going on in the district, to appoint a guard, to discharge a guard, to recruit a guard, if there is theft or any incident in the company, the 2nd party will have to immediately reach there and solve the problem. One cannot reach.
41. After the completion of 20 days' duty of the guard after the approval of the 2nd party, the guard will get only up to Rs 1000-2000 in his account as an advance.
42. The service provider company will provide salary to the employees only after receiving the salary from the service receiver company.

43. The 2nd party will employ guards in the same company which will pay salary in the company account or by check, will not work in cash.
44. The 2nd party himself and any of his sub-ordinate employees will not reach the service receiver company in a state of intoxication.
45. It will be the responsibility of the 2nd party to present the attendance alert of all the employees in the SGS Pvt. Ltd. office on 1st date of every month.
46. Any employee will not be treated like assault indecency by the 2nd party.
47. The 2nd party will never leave unfinished work.
48. Both the parties will ensure that in which company in the district the guards are to be deployed or not.
49. It will be the responsibility of the 2nd party to collect information about the company, whether there is any fraud that has provided payment to the previous company and then the company is changing.
50. It will be the responsibility of the 2nd party to employ only those guards who are skilled in the work and the employees are skilled in behaving well with the public.
51. The 2nd party will act with absolute integrity & conduct in good faith with the employee of Alert SGS Pvt. Ltd.
52. It is mandatory for the 2nd party to follow all the rules of the company.
53. All the documents will be recorded in the name of 1st party only.
54. If the work of the 2nd party is good, then the company can include its shareholder in the director list.
55. This agreement has been made with mutual consent between both the parties. It is completely illegal to give this paper to any other person.
